The week was comprised of 42 lightening talks, 11 demos, and 4 tutorials. There were 487 unique registrants and 398 unique attendees across all five days.

# **DEMONSTRATIONS (20 min)**

## ArcGIS Dashboard for Covid-19: Kathy Tang

An ArcGIS Dashboard is a powerful tool for displaying multiple visualizations of your data on a single screen without writing any code. With COVID 19 pandemic, ArcGIS dashboards have become extremely popular to display information about the pandemic. In this demo, I will begin with an overview of ArcGIS Dashboards and then show you how to create a simple dashboard using real-time COVID 19 data provided by the Centre for Systems Science and Engineering at Johns Hopkins University.

## Finding Historical Topographic Maps in the Scholars GeoPortal: Amber Leahey

There are thousands of historical scanned maps in the Scholars GeoPortal available for open reuse. The 1:63,360 and 1:25,000 scale topographic maps were the first historical series to be inventoried and georeferenced by the Ontario academic library community for open access in 2017. Now we've added maps covering all of Ontario at the 1:50,000 scale, representing a rich set of historical topographic data to be used for all sorts of historical and longitudinal research. Join me for a demonstration of how to find, access, preview, and reuse these amazing historical maps in the GeoPortal!

# GIS Working Group Open Meeting: Liz Sutherland

I founded the London GIS Working Group in 2017 after a GIS Open House event that had us GIS professionals chatting about wanting more time to nerd out over maps/GIS. The group meets about once every quarter, with an open virtual networking event during GIS Days. This session will be run as a Zoom Meeting as opposed to a Webinar. This is an open meeting, meaning anyone who is interested in learning about GIS jobs and listening to GIS professionals is welcome to attend. The session will run as a show-and-tell round table.

## HGIS and Local Museums - Why the Future of Collections Management Systems is Spatial: Ben Woodward and Julia Armstrong

Our presentation will begin with a demonstration of the Bayfield Historical Web Map (https://www.bayfieldhistoricalwebmap.ca/), an innovative HGIS that can be used to explore the Bayfield Historical Society's georeferenced collection of historical maps, photographs, and postcards. We will then provide a high-level overview on how we created the map, something we achieved using exclusively open-source tools, including OpenLayers, Django, and PostgreSQL/PostGIS. Lastly, we will compare the Bayfield Historical Web Map to other collections management solutions (e.g. PastPerfect and Atom) and outline the pros and cons of this approach for local museums and archives, researchers, and the general public.

## **Open-source software for Geospatial Data Discovery, Exploration and Reuse: Kevin** Worthington

As the open data movement continues to gain traction, research communities need systems that allow not only online data discovery, but also their exploration and reuse. The ability to view, combine, and interact with data online prior to download helps to assess data suitability, subset data as needed, and pipe data into existing analyses systems; to streamline data gathering and research efforts. With a focus on geospatial data, the developed open-source software makes this possible. It is designed for academic libraries to harmonize research data across platforms and provide researches with a consistent interface to access data. This open-source software leverages existing technologies to facilitate harvesting, curation, and ingestion of these data.

# Discussing "Geo" Job Opportunities & Skills: Jonathan Murphy

This special 1-hr presentation will focus on the geospatial job market in Canada and

internationally. This talk will be of interest to those wishing to understand current and future trends relating to their careers. Jon will be joined by Prashant Shukle and Bilyana Anicic to discuss the following topics: • What is the geospatial job market like right now? What has the pandemic done to change the way we work? What if any impact on the geomatics community? What are the new skills and new opportunities opening up in the job market? Are their opportunities for young entrepreneurs? If so what?

# Processing big geospatial data using FME Workbench and other cool tricks to get your desired output: Meaghan Kenny

This presentation will highlight the benefits and barriers to using FME to process large (3TB) datasets. Processes include reading in the data and clipping to an area of interest (Ottawa, ON), using Ward boundaries as fanout folders. I will offer a brief demo of how quickly you can get to your desired output.

### The Geography of Pokémon GO: Vivian Kong

This presentation will talk about the history of Pokémon GO and the different GIS processes that are used to create the widely successful augmented reality mobile game, as well as a brief discussion on the use of GIS in other games. A live demonstration of Pokémon GO will also be presented (technology permitting).

# Tracking COVID-19 in Low- and middle-income (LMIC) countries using open source GIS tools: Crystal Wai

We present an interactive R Shiny app called "COVIDEpisim" to capture the spatiotemporal transmission dynamics of the spread of COVID-19 in Low- and middle-income (LMIC) countries. Our app uses open-source GIS tools and freely available population count data downloaded as a gridded raster map at the 30-arc second resolution from WorldPop (www.worldpop.org) to assess the geographical spread of COVID-19. We consider Nigeria as a test case and use the daily COVID-19 incidence, prevalence, vaccination and death data retrieved from the Nigerian Centers for Disease Control (NCDC) webpage. We implement a SVEIRD (which stands for Susceptible, Vaccinated, Exposed, Infectious, Recovered and Dead compartments) epidemic model. Our simulation provides insight that would support the Public Health officials towards informed, data-driven decision making and more broadly on how COVID-19 spreads in a large geographical area with places where no empirical data is recorded or observed.

# Using Google Earth and Census Data to Explore your City's Spatial Structure: David Gordon

The Canadian Suburbs research project used census data and ArcMap to classify every metropolitan neighbourhood to answer the research question, 'Is Canada a Suburban Nation?' [Answer: Yes]. This research demonstrated that 67% of the Canadian population resides in suburbs and maps the spatial structure of metropolitan areas. The research method and an atlas can be found in the report Still Suburban? www.canu.ca/resources The maps and data are also available at our research website CanadianSuburbs.ca and can be downloaded to explore in Google Earth.

We will demonstrate the research method, give a lightning tour of all 33 metropolitan areas and give a live demonstration on the use of the Google Earth version.

#### What to Expect When You're Mapping: John Nelson

Let's make a map together! Why not, it's a blast and we all know it. But our bosses have to think it's all serious work. We will build a map in ArcGIS Pro and chat about why each step is taken.

#### A Snapshot of COFI's Forest Education Program: Jim Costley

A snapshot of COFI's Forest Education Program. Attendees will be introduced to the many forestry career awareness programs that COFI hosts throughout the province and learn how COFI's forest education program connects students, teachers, and parents to Forestry and the Forest Industry.

# Additional Dwelling Area (ADU) Estimation in GIS: Application to the City of Windsor, Ontario, Canada: Terence Dimatulac

Acquiring a home in Canada, whether through buying or renting, has been financially challenging in recent years. Therefore, introducing a second residential unit, also known as additional dwelling unit (ADU), could be seen as a potential solution to this dilemma by providing more affordable housing for many. In this project, a model was develop using the ModelBuilder in ArcGIS to estimate the available area for an ADU on each land parcel in the City of Windsor in Ontario, Canada. Then, a categorical model was used to determine if a specific ADU complies with the constraints put on by the city. In general, more than 94% of the residential parcel in the City of Windsor have enough area to house an ADU. Among them, about 44% are eligible to have a detached ADU, while more than 40% are eligible to have an attached or interior ADUs.

# Development of a GIS tool for integrating road infrastructure risk analysis associated with the geomorphological dynamics of watercourses: William Massey

The research project aims to develop a GIS analysis tool to identify the sectors or infrastructures of road networks that are or may become vulnerable in relation to the geomorphological dynamics of rivers. The three-year project funded by the Quebec Ministry of Transport, is composed of two main phases, the first of which consists of tool development and testing on the project to extend Route 138 (addition of roughly 375 km) in the Basse-Côte-Nord region of Quebec, while in the second phase the application of the tool will be extended to several other watersheds representing the range of physiographic regions and fluvial styles found in the province. The presentation highlights the use of GIS for identifying geomorphological hazards in remote locations and assessing risk for road infrastructures through tool development and interpretation of indices evaluated from LiDAR, historical aerial photos and satellite imagery.

# Ecological Connectivity/Restoration Project outside of Point Pelee National Park: Tom Dufour

In support of this collaborative project with Parks Canada, GIS staff at ERCA will show how GIS proximity and allocation tools were used to identify and prioritize areas for potential restoration and conservation in the watersheds immediately north of Point Pelee National Park in Essex County, Ontario. The ultimate goal was to focus on high priority opportunities to restore features and ecological functions that have been lost or degraded while maximizing ecological benefits. Highlighted inputs include natural heritage mapping and species of interest records which were used to produce the areas of targeted restoration opportunities.

### **Empowering the Human-Nature Bond: Valeria Widjaja**

What is land? Is it dirt, the Earth, property, a resource? But rarely we ask who is land? When we change the question, it changes the way we think about land. It transforms the way we make decisions about how we might protect land. Through the Deshkan Ziibi Conservation Impact Bond, this story map explores how Carolinian Canada, Chippewas of the Thames First Nations, VERGE Capital, Ivey Business School, Thames Talbot Land Trust, and 3M are striving to heal the

landscape. Overall, this story map visualizes both the human-nature and human-human relationships being facilitated by the bond. Learn the about stories of the Carolinian Zone, who we are trying to save, the tools used, the work being done, and how diverse groups came together to achieve one common goal: to preserve our ecosystems and unite various sectors and challenge the assumptions society holds about nature and its role in human life.

### **Estimating Ecosystem Processes from Autonomous Underwater Gliders in the Great Lakes:** Nolan Pearce

This presentation will provide an overview of the use of autonomous underwater gliders for data collection in the Great Lakes by the Real-Time Aquatic Ecosystem Observation Network (RAEON). Second, this presentation will provide an introduction to using autonomous time-series measurements to estimate ecosystem processes across large spatial extents.

#### **Evaluating Effect of Tree Canopy Cover on Human Thermal Comfort: Arthur Dolinar**

The project is about evaluating the effect of tree canopy coverage on human thermal comfort done by using comfort indices and the software ENVI-met to complete the analysis.

#### Galaxy Mapping by Machine Learning Classification: Robin Kwik

My presentation highlights the compatibility of remote sensing and astronomy methods. Here I discuss the classification of galaxy components in UGC 2885, a massive spiral galaxy, by machine learning; in particular, I compare the traditional method of maximum likelihood with the more powerful models random forest and support vector machine.

# Getting a Ley of the Land: Fostering Urban Legibility Through Ley Line Mapping: Colton Sherman

Cities are challenging texts to decipher, but the task is not impossible. In adapting Alfred Watkins's (1925) widely criticized theory of Ley Lines (or 'routes of power'), I posit that we can establish a methodology for deciphering these urban enigmas in a wholly unique way, facilitating orientation within these spaces which goes beyond the mere use of street signs and other textual signifiers. How a city allows or denies access goes virtually unnoticed by the wanderer, but adapting Watkins's ideas and charting numerous urban elements (coffeeshops, graffitied walls, traffic hotspots, etc.) exposes narratives of facilitation and interruption, and literally gives shape to a city's multiplicity. This method also highlights sites of psychical overlap hitherto unnoticed by wanderers, exposing intersections and parallels between disparate elements. Despite the pseudo-scientific reputation of Watkins's theory, it nonetheless facilitates a new way of reading a space resistant to legibility.

### GIS in Telecommunications: Usage of spatial databases: Justin Sungsoon Chang

My presentation will be about using GIS in the world of telecommunications. I would like to highlight how multi-user environment in GIS powered by spatial databases enables users to work from different locations and in a synchronous way.

#### GIS and the United Nations Sustainable Development Goals: Amit Arora

My talk will touch upon the United Nations Sustainable Development Goals. I will provide an overview of GIS applications in accomplishing one or more of these goals.

## Google Earth Engine: A Case Study in Forest Cover and Landscape Metric Calculation: Miranda Postma

A brief case-study in how Google Earth Engine can be useful for studying changes in forest cover over time. This presentation will be looking specifically at the JavaScript (browser-based) version of Google Earth Engine, and will be examining its strengths and weaknesses when it comes to generating forest cover layers and calculating landscape metrics.

#### Herzberg50: Benjamin Harris

The Herzberg50 project, done by Defining Moments Canada, commemorates the life of Gerhard Herzberg, the 1971 Nobel Laureate in Chemistry. This map was created to be a resource for teachers and students to visualize Herzberg's life, and to make connections with events that were occurring at the time. The project is also significant as a biographical resource, as it shows how different mediums can be used to write in-depth biographies.

#### How GIS Applications Help us to Rethink our Relationship with the Nature: Leo Poon

I am one of the volunteers from GoGeomatics. Our team publishes weekly digest to cover local (Canadian) and international geospatial news. I am going to summarize what we have covered so far for the Canadian geomatics industry from January to September, particularly focusing on mapping applications related to environmental monitoring. I am still finalizing which stories to be discussed for the presentation, but most likely will focus on how the general public can be benefited from recently developed GIS applications and technological advancements, and how the Canadian government sectors and private corporations contribute to these developments.

## Impact of Urban Development on the Long-term Viability of a Blanding's Turtle Population: Anne-Christine Auge

Habitat change due to urbanization have had negative impacts on turtle populations worldwide. I studied an urban Blanding's turtle population to assess whether development was compatible with population viability. I investigated turtle habitat suitability using habitat suitability modelling in ArcGIS, and monitored locations and survival 2017-2020 (ongoing development) using telemetry and mark-recapture. I made comparisons to data collected 2010-2013 (prior to development) to assess whether population viability declined through increased habitat loss and lower population size. I found that turtle habitat suitability declined by 10% over the last decade, and population size decreased by 70%. Population modelling suggests that 2 road mortalities per year could explain the decline in the population size, which is likely related to habitat loss forcing turtles onto roads. Moreover, this estimated road mortality rate is not sustainable over the next 50 years.

#### Investigating Climate Change Basics Using Storymaps; Beth Hundey and Katrina Moser

I'm part of an interdisciplinary team that's creating a new online course, Connecting for Climate Change Action. As part of this project, I've used storymaps and survey 123 to support students in learning some climate change basics. The learning objects are intended to give students more time working and interacting with key figures, rather than listen to the instructor explain them. Aside from interactive images and graphs, students can also check their understanding with immediate feedback. Students also have a new way to share their photography and reflections with eachother using survey123.

### MCE Geo Hub: Ryan Fortier

The Mapping and Charting Establishment of the Canadian Armed Forces Web Services Section developed a Geo Hub providing members of the CAF and DND community a variety of web mapping services in support on domestic operations (fires, floods, etc). This was created using the AGOL platform.

# Mapping as Problem-Solving: Adopting a Geospatial Approach to the Study of Inclusive Education:Alexandra Minuk

To understand the regional variables associated with inclusive classroom placement for students with autism spectrum disorder in Ontario, it was first necessary to identify the best measure of region. Since publicly available data on the 72 school boards is limited, we needed a way to create our own. This presentation is about mapping as problem-solving and how inter-disciplinary collaboration can be illuminating. In our lightning talk, we will highlight how we used ArcMap to visualize inclusive classroom placement for students with autism spectrum disorder, as well as our use of CHASS to summarize census variables of interest as they fit within the school board boundaries. Not only did the maps allow us to identify areas that might require additional support in implementing inclusive placements, but also, the resultant summary statistics allowed us to calculate more precise correlations between classroom placement and the variables of interest.

### Mapping Coastal Erosion Disadvantage in Scotland: Craig MacDonell

Despite accelerated rates of coastal erosion and growing coastal populations, global understanding of the relative resilience of communities to coastal erosion is limited yet social justice and climate justice are key emerging issues of concern for governments. For the first time in the UK, using Scotland as an exemplar, this work aims to couple GIS analysis of anticipated erosion risk with consideration of the social vulnerability of Scotland's communities, to produce Coastal Erosion Disadvantage maps. A Social Vulnerability Classification Index was derived using a series of deprivation and context-specific indicators. The analysis also compared coastal communities with the Scottish average in terms of vulnerability, as well as a worst-case scenario of a "High Emissions Scenario", and no future maintenance of current coastal defences. This yielded impactful results which will hopefully be a catalyst for further assessments of social vulnerability to erosion for at risk communities.

#### Mapping Farmstead-Sanctuary Connectivity using Least Cost Path: Christine Davidson

Topographic anomalies identified in 1950's aerial photography along the Ionian Coast of southern Italy suggest systematic separation of space surrounding the ancient Greek settlement of Metaponto. Are these proof of property delineation in the countryside, systems of travel, or entirely natural? Using least cost path, we connect ancient farmsteads with local sanctuaries, revealing overlap with the anomalous "division lines," suggesting that they functioned (at least in part) as communication throughout the countryside.

#### Mapping Library Fellowships with ArcGIS StoryMaps: Jason Dyck

Several research libraries offer fellowships to faculty members and graduate students, but they are not always easy to find. Since these collections are scattered across various countries, there is not one central way of searching for them. To assist graduate students in the Arts and Humanities at Western University, I created a brief introduction to library fellowships using ArcGIS Story Maps. "Library Fellowships: A Brief Introduction" offers an overview of the types of fellowships available, a list of some of their benefits for researchers, and some advice on how to write a strong proposal. It also features an interactive map pinpointing applicants to private and university libraries across the United States and other parts of the world that offer library fellowships. In this lightning talk, I offer a brief explanation of why StoryMaps are useful tools for educating graduate students on library research beyond their own institution.

#### Mapping Like a 6th grader: Lauren Sinclair

Whether you want to teach GIS to middle schoolers or have fun learning GIS in Mrs. Sinclair's classroom, join us for a mix of hands-on activities, resource sharing, and multimedia showing what kids as young as 10 are doing with GIS. If they can do it, so can you! GeoInquiries, ArcGIS Online school accounts, data collection apps, and StoryMaps will be explored alongside GIS tools like cardboard and playdoh.

# Mapping Medieval Flood Mitigation Strategies for AR Educational Gaming by Zack MacDonald

This talk provides a brief overview of our efforts to reconstruct virtually the late-medieval village of Northeye in the coastal salt marshes of the Pevensey Levels in East Sussex, England. I'll demonstrate how we used ArcGIS Pro and ArcGIS online to synthesize documentary evidence, hidden maps, historic maps, and remote sensing data to model the thirteenth- and fourteenth-century flood mitigation efforts around Northeye, and how the resulting HGIS is being used to generate a pedagogical video game styled after classic Tower Defense games.

### Mapping the sporting wealth of a community: Abby Perfetti

This presentation looks at the community sport landscape in London, Ontario using a geospatial map created on the ArcGIS Online platform.

#### Mapping Works in German Literature for a Digital Humanities Course: Rene Duplain

This presentation will provide an overview of an ongoing collaboration between a professor in German translation and the University of Ottawa Library. Along with a few library colleagues, I am helping show undergrad students in ALG2300: Masterpieces in German Literature in Translation the power of mapping using ArcGIS Online to explore selected works in German literature and illustrate meaningful events occurring in works across historical Berlin and Venice.

### M & M - Muskox and Movement: Hayleigh Conway and Paden Lennie

Using collar data to track species of interest to better understand their movements and use of habitat. Managing and visualizing collar data using ArcGIS Pro, doing aerial surveys using Avenza Maps and Fulcrum.

# Municipal Elections in Quebec: How Political Parties Can Strengthen the Democratic Process: Amanda Gutzke

This storyboard examines the 2017 Quebec mayoral elections. Specifically, this storyboard explores rates of incumbent re-election, elections won by acclamation and the impact of political parties on the democratic process. I also use ArcGIS software to provide a visualization of the 2017 mayoral elections in Quebec. Over the course of my analysis, I found that the rates of incumbent re-election and elections won by acclamation were extremely high. However, I also found that these rates are lower in urban centres that have political parties. After examining the role of political parties within municipal elections, I conclude that political parties benefit the democratic process. Political parties help individuals challenge incumbents by providing an organizational structure to engage volunteers, receive donations, and mobilize supporters. Finally, I support this argument by referencing other work done in the field of urban and local governance.

#### **Munsee-Delaware Map: Claudia Jones**

Mapping sites of historical significance for the Munsee-Delaware community. This map uses the survey 123 app to create data points of significance. This database consists of maps highlighting common themes such as Ceremonial Grounds. Additionally, the map highlights location types and categorizes events relating to the history of the Munsee-Delaware people.

#### **Open Educational Resources and GIS: Emily Carlisle-Johnston**

It's no secret that textbooks can be expensive. The good news is, Open Educational Resources (OER) offer an accessible and engaging alternative to commercial textbooks and course materials. In my lightning talk, I'll provide an overview of Open Educational Resources (OER) and the benefit that they have to students, faculty, and instructors. I'll link OER to GIS by doing a Show and Tell of GIS-focused OER, before concluding with a message about how you can get started with using or creating them.

#### Quantifying Aquatic Macrophytes with Satellite, Drone, and Rake Data: Robert Bailey

I want to use multi-spectral Landsat satellite images to quantify macrophyte growth in the Kawartha Lakes. But first I have to ground-truth the satellite data with drone images and ground-truth the drone data with rake sampling. I'll show how we do this with GloVis, QGIS, DJI GS Pro, Metashape Pro, and Navionics, along with my post doc (Dr. One), my honours student (Andy Mo), and a rake!

### **Researching Military Service using Geovisualization in Eleventh to Twelfth Century** Normandy: Christopher Hewitt

In the eleventh and twelfth centuries, the Duchy of Normandy was an important source for military adventurers at the time. While much has been written about those soldiers who fought on these campaigns, surprisingly little has been written about where they had originated. To address this anomaly, this study demonstrates the value of geographic-based analysis through the use of historical geographic information systems (HGIS) techniques including mapping locations as well as performing nearest neighbour analysis and kernel density mapping. The analysis focuses on participation in the Norman Conquest of England in 1066. The results indicate that participation varied spatially which was the result of patronage in certain parts of the duchy. The presentation concludes with a discussion of the implications of these findings for the veracity of existing historical accounts on the battle, as well as options for and benefits of applying HGIS analysis to other historical events.

# Sites of the 'Second Wave': Mapping London Women's History: Sophie Thompson and Sydney Cabral-Poleck

Starting with a static map of second-wave women's history sites, students are creating a vivid Storymap that documents the history of women's activist organizations in London, Ontario, in the 1960s and 1970s. The presentation offers an update on the work-in-progress, and reflects on the significance of the work in contemporary context.

#### **StoryMapping Queer Dallas: Isaac Williams**

This presentation discusses the Queer Dallas StoryMap, a project highlighting queer history in Dallas, Texas. The American South is home to a rich history (and present) of queer life, organizing, survival, and joy. The project's goal was to make this history more visible, both to Southerners and people who live elsewhere. The presentation will discuss resources used in the creation of the project (including community archives and articles by feminist scholars, including Alexandra Ketchum), decisions made in the visualization process, and ways that the project was shared.

### The Interaction of Deer and Hunters in Oklahoma, USA: Caitlyn North

Over the past summer I completed a research project that looked at the spatial distributions of deer and hunters in Oklahoma and how they interacted. Using ArcGIS pro I was able to analyse and draw conclusions on the data. I leveraged the python notebooks within ArcGIS pro to clean the data as well as perform analysis.

#### The Loyalist Migration Project: Jacob Vanderhoeven

My presentation will focus on an GIS map I prepared with Professor Compeau over the last two summers. The Map presents the genealogical information for hundreds of Loyalist refugees as they emigrated from their homelands in the newly founded United States.

#### The Northern Tornadoes Project - Mapping Canada's Tornadoes: Aaron Jaffe

The Northern Tornadoes Project is a collaboration between Western University, ImpactWX, and several other parties that aims to improve the detection, prediction, and mitigation of tornadoes across Canada. Many of the captured tornadoes are documented via interactive online maps in ArcGIS Online. These maps combine data captured from various sources, including Survey123 on the ground and drones in the air.

#### Understanding electrification solutions: Benjamin Stewart

The Global Electrification Platform (GEP) is an open access, interactive, online platform that allows for overview of electrification investment scenarios for a selection of countries. The scenarios present pathways for achieving universal electricity access, split into an intermediate strategy for 2025 and full electrification by 2030. Users can explore 96 different scenarios to meet the access goals. These different combinations and parameters are presented in the form of "levers". Users can overlay additional layers as well (e.g. wind potential, electricity networks, location of health facilities) to help illustrate useful contextual information about a selected country.

# Urban Tree Canopy Assessment Using Geospatial Technologies: A Case Study of the Town of Lincoln, Ontario: Baharak Razaghirad

Urban trees provide important benefits to communities yet municipalities across Ontario are encountering a decline in their urban tree canopy (UTC). UTC assessment is critical for the management of urban trees, especially in the context of climate change. Geospatial technologies provide a timely and accurate alternative to costly, ground-based assessments. However, they typically require a significant investment in resources, including technical expertise and equipment. For many small-sized municipalities facing the realities of climate change, these investments are cost-prohibitive. The purpose of this study is to assess the UTC within the Town of Lincoln, Ontario, using two different approaches to quantifying the UTC (i.e., remote sensing and a random sampling method). Results indicate that the two approaches are similar in their estimates of the UTC such that the lower-cost option (i.e., random sampling using i-Tree Canopy) may be more appropriate for resource-limited communities.

Using GIS to Re-imagine Historical Niagara: Jessica Linzel

In this presentation I will explain how I incorporated historical GIS into my History Master's thesis last year. For this project I used ArcGIS Pro to create a Web Map, which I then used to investigate Niagara's economic development in the post-Revolutionary "Loyalist" era. Mapping historical data from account books and ledgers, and analyzing it alongside geographical features in the Niagara region, GIS technologies allowed me to bring a fresh perspective to a familiar topic.

#### Watershed Creation and Where does water flow?: Terry Chapman

Presentation will briefly review the process followed to generate small to midsized watershed boundaries for the Upper Thames River Conservation Authority Watershed, using LiDAR data and ArcHydro tools. Though not proven, some unique conditions were found when new boundaries were created. Some examples or flow patterns and watershed outlets will be shared.

# Weather Extremes in England's Little Ice Age, 1500-1700: Madeline Bassnett and Daryl Wakunick

We will provide an overview of the project, data collection and demonstrate the GIS database.
