#### PROVINCIAL ARCHIVES OF MANITOBA

#### MAP COLLECTION

The map collection of the Provincial Archives of Manitoba has been struggling for the last number of years to maintain some semblance of order in the face of a serious space problem. This problem should be somewhat alleviated during the fall of 1974 when the Archives moves to its new and larger quarters.

The collection currently housed in the Provincial Archives is relatively small but will be substantially augmented once the move is completed with the transfer from the Surveys Branch of the Department of Mines, Resources and Environmental Management of a large collection of archival maps and surveyors notebooks and notably the Hudson's Bay Company's Collection.

The emphasis of the collection is on the area now within the boundary of the Province of Manitoba but because of their related development sections of the Prairie Provinces and Eastern Ontario are also represented.

A small but important part of the collection are maps from the eighteenth and nineteenth centuries which portray the expansion of exploration in the Canadian West. One of the more beautiful of these is the 1848 manuscript map of "Upper Fort Garry and its Immediate Vicinity" surveyed and drawn by members of the Royal Engineers.

The bulk of the collection, however, consists of maps issued after 1870 which deal with the expansion of the surveying system; the sale, distribution and use of land; and the growth of the transportation and communication network. These maps were for the most part published by both the Federal and Provincial Governments, the Hudson's Bay Company, Real Estate Developers or Canadian Pacific Railway. One set of maps becoming more frequently used is the Cummins Land Map Series published between 1915-1918 which give the ownership of every quarter section of land in most of Manitoba, Saskatchewan and Alberta.

The growth and development of the City of Winnipeg is documented with such various maps as the ever popular Birds' Eye Views (1880, 1881, 1882, 1884) or the Atlases (1917) put out by the Western Canada Fire Underwriters Association. Unfortunately the other urban areas are not so adequately covered.

The manuscript and photograph divisions of the Archives have many items which supplement the map collection. For example there is the original Field Survey Book of A.C. Webb for 1869 with the notation about his survey party being stopped by a group of Metis led by Louis Riel or an album of photographs taken by the photographers accompanying Her Majesty's North American Boundary Commission on its survey of the International Boundary between Lake of the Woods and the Rocky Mountains, 1872-1874.

The Provincial Archives of Manitoba does not lend items from its collection. However, copies of most of the maps can be made available upon request at reasonable cost.

#### A SUPERPORT AT PORT OF SOUTH VANCOUVER!

The Special Collections Division of University of British Columbia Library has recently acquired a rather interesting old wall map, on which hangs a tale. The map is:

Map shewing Greater Vancouver and suburbs, railway, dock & manufacturing facilities, and properties of Vancouver Dock & Harbour Extension Co. Ltd. at Port of South Vancouver; compiled & copyrighted for Pretty's Timber Exchange Ltd. Vancouver, B.C. [printed by] B.C. Drafting & Blue Printing Co., Williams Bldg, Vancouver.

The map is blue printing on tracing linen, to which has been added in red, proposed docks and manufacturing site covering the tide-flats west of bulu Island. This scheme intrigued me for two reasons. I knew that many years earlier there had been a scheme to build a superport, and this map came to us with others all dated 1911-13. On checking the directories for Pretty's Timber Exchange and B.C. Drafting, I found the map had to date between 1908 and 1916. As the P.G.E. was shown as "(Proposed) Yukon Railway Extension", it had to be before 1914. But what of the Vancouver Dock & Harbour Extension Co. Ltd.? On visiting the City Archives, I consulted Bill McKee, and sure enough, Major Matthews had kept a docket which supplied the answer!

The superport at Roberts Bank was not a new dream. In 1912 Charles Fenn Pretty, president of Pretty's Timber Exchange, Ltd., formed the Vancouver Harbour and Dock Extension Co., with a capitalization of \$10 million. One report says "with Mr. Pretty are associated a number of leading financiers and some very strong capitalists and successful harbor builders of the first ports in the world." Pretty was president and managing director, and Thomas T. Dauphinee, manager of Pretty's Timber Exchange, was secretary. The Vancouver World of May 18, 1912, records the scheme as outlined by Dauphinee and F. Wooley, the company's engineer, at a meeting of the Richmond Progressive Association in Steveston. The scheme proposed reclaiming the tidal-flats west of Lulu Island, converting 8.4 square miles into harbour area, consisting of 35 square miles of enclosed waters, and 4.9 square miles of area on the piers for working dock area, warehouse and storage shed area, industrial sites, terminal trackage, and handling facilities. The financing was to come from New York or Europe, and \$20 million would be spent within the next three years on the first three piers. There were to be 6 piers, each 1 1/2 miles long, and 1/4 to 1/2 miles wide. Sawmills and other industries would be located on reclaimed land west of the dock facilities. The 10 1/2 miles of dock frontage would provide 33 warehouses and storage areas, 44 blocks on piers for various industrial purposes, 57 miles of tracks, 3 lift drawbridges, and a double track tunnel. Apparently the Company did not get its financial backing, as construction does not seem to have begun before the outbreak of War, and once again the dream died. However, Mr. Pretty's descendants are still active in the lumber industry, and Pretty's Timber Co. Etd. is still in business.

In 1966 the National Harbours Board extended the Port of Vancouver south to the international border, and commissioned Swan Wooster Engineering Ltd. to recommend a site and plan a superport. In October 1967 a thirty-year plan was announced, and construction began the following year.

Minutes of executive meeting held in Ottawa at the Public Archives on March 5, 1974

#### 1) Committee Reports

#### a) Publications

The report from Edward Dahl (See Appendix A), Chairman of the Publications Committee was accepted with the provisio that Newsletters, both back issues and current, be available only to A.C.M.L. members. Non-members requesting Newsletters are to be advised that the Newsletter is an internal publication and membership information should be sent to them.

Mr. Dahl gave a report on the status of the 1973 Proceedings which he and Mr. Hayward are editing. It is planned to publish and distribute the Proceedings before the conference in June.

Frances Woodward moved that the A.C.M.L. not distribute any publication or membership through agencies. The motion was seconded by Carl Harvey. The executive voted to accept the motion.

After some discussion about the future role of editor of the Proceedings, it was agreed that the Editor of the Proceedings be a member of the Publications Committee, but not necessarily the Chairman, and not necessarily from the National Map Collection; it was also agreed that the person within the National Map Collection responsible for the distribution of publications be a member of the Publications Committee but not necessarily the Chairman.

#### b) Awards

Since T.E. Layng, the previous chairman of this committee has retired, Lorne Leafloor is now chairman. Mr. Leafloor was unable to be present but had discussed several points with Betty Kidd.

It was recommended that Mr. Leafloor write and circulate the Terms of Reference for the committee and for judging of papers as soon as possible. The terms of reference should be broader than those discussed in Banff, to include a more general type of award. The executive felt that there

should still be an attempt to present an award this year.

#### c) N.U.C. Maps

Hugo Stibbe submitted a written interim report (See Appendix B) to the members of the executive. The report was tabled.

Arising from this report was the question of the present chairman's resignation as of January 1974 (retroactively); Mrs. Kidd moved that a) because of the state of the cataloguing rules for single thematic maps and b) because, of the three persons nominated during the N.U.C. meeting, two qualified their nomination in that they were unable to assume the responsibilities before the June conference, Mr. Stibbe be asked to continue in the chairmanship until June when the problem should be brought to the membership-at-large at the annual business meeting. This motion was accepted, with several abstentions.

#### d) Layout

At the time of the meeting there was no report available. However, Serge Sauer reported by phone shortly after the meeting that he is preparing 2 or 3 lay-outs - he will have one printed at his own expense to be shown to the executive at the executive meeting in June.

#### e) Directory

Yves Tessier, one of the joint chairmen of the committee, reported that he had no detailed report available. He is maintaining an information file on Quebec map Libraries.

It was suggested that the committee meet if possible (at the moment, the members are Yves Tessier, Joan Winearls, Carl Harvey and Dave Dairon) and that recommendations be prepared by the time of the annual business meeting.

#### f) Advertising

Frances Woodward presented a brief report in which she recommended that draft letters and a list of journals she had compiled be turned over to the secretary for further action. She feels that the letters should be sent from the executive, not from a committee. The executive accepted her recommendation.

#### 2) Treasurer's Report

Ms. Carl Harvey presented the treasurer's report (see Appendix C). It was noted that the publications account was not included; with the publications account, the total balance was \$2,419.98.

The executive agreed that a special thank-you was owing to Carl Harvey f r her efforts in the financial area.

Ms. Harvey will look into the feasibility of an audit before the June conference; the executive agreed that Ms. Harvey's decision would be acceptable.

The executive wished to place on record its recommendation that tree lling funds be made available to executive members to attend one executive meeting per year, if funds were not available from the member's institution.

It was decided that no further action should be taken on the provision of funds to A.C.M.E. members attending the annual conference.

#### 3) Report on 1974 Conference plans

Before discussing the 1974 Conference, Mrs. Kidd reported that an official complaint was sent to the Banff Conference Centre concerning accommodation and meal arrangements during the 1973 conference; no reply was received.

Joan Winearls, in a phone conversation with Mrs. Kidd earlier in the day had reported that arrangements were progressing well and that A.C.M.L. members would be allowed free entrance to all SLA G & M functions (except paid functions, such as luncheons). Pre-registration forms were to be mailed with or before the next Newsletter from Ottawa to all members.

#### 4) Report on Newsletters, 1973-74

Miss Woodward reported that one Newsletter had been printed and distributed, a second was being typed and she hoped that a third would be published prior to the June conference.

Confusion in the numbering system resulted in the last Newsletter (i.e. October 1973) being incorrectly numbered - it should have read Vol. 6, No. 3. Mr. Dahl moved that starting with the Newsletter then being typed that a consecutive numbering system be instituted. Seconded by Yves Tessier; the motion was accepted.

#### 5) Facsimile Committee

Miss Woodward raised the question of the status of the Facsimile Committee. While most had considered the committee defunct, this was never properly clarified. The executive confirmed that the committee had ceased to function and was defunct.

#### 6) Constitutional Changes

Four problem areas in the constitution were proposed for discussion.

In the first, Mrs. Kidd proposed considering a name changeto the Association of Canadian Map Collections. Because of divergent opinions, this was not pursued since all agreed that the Association, whatever its name, was too important to split over the issue.

The second problem was types of membership. There are numerous examples of persons being listed as active members, who should be associate; and institutional members, who should be associate. H. Stibbe suggested that individual membership should be the cheapest. It was agreed that this and the other problems of the A.C.M.L. year and types of committees should be referred to a standing constitution revision committee.

#### 7) Report on a Canadian Federation for Cartography

The minutes of the organizational meeting held January 18, 1974 in Toronto were distributed; Joan Winearls attended as A.C.M.L. representative.

The executive consented to A.C.M.L. involvement and support; the executive will recommend consent from the membership-at-large at the annual business meeting.

#### 8) Status of proposed manual

The recent publication of the Drexel Quaterly special issue on map librarianship has resulted in the <u>Cartographica</u> officials no longer being interested in publishing an issue based on the A.C.M.L. manual papers.

Miss Winearls recommended to Mrs. Kidd, if the executive agreed, to return all papers to the contributors.

Various proposals of ways to publish the papers were discussed - it was agreed that most, if not all, were in need of revision.

#### 9) Extension of bilingual services

The A.C.M.L. constitution is to be translated to French and circulated to all French-speaking members. Contributions in French for the Newsletter are to be encouraged. The annual conference is usually almost totally English; thus there is no attraction for French-speaking members to attend. Instantaneous translation appears to be the only solution but is not economically feasible at this time.

#### 10) Regional groups and grants

The discussion on extension of bilingual services developed into discussion of moral and financial support for regional groups from the national group. It was accepted that the membership—at-large should be made aware of the financial grants available from the A.C.M.L. to hold regional meetings in the next Newsletter.

Regional groups should not yet be formalized - the feeling was that these groups should be allowed to develop naturally.

#### 11) Planning a membership campaign

Mrs. Kidd reported that despite good intentions, membership letters had not yet been sent to possible future members of the A.C.M.L. At the present time, old membership lists are being reviewed to compile a list of persons who are no longer members.

It was agreed that a revised brochure should be printed, but because of possible changes in membership types, fee structures, etc., it was the consensus that the subject should be discussed again in June.

#### 12) Canadian Association of Geographers

Mrs. Kidd reported that a letter was recently sent from the C.A.G. to the Secretary of State supporting the resolutions proposed by the A.C.M.L. in 1969 concerning the deposit regulations for maps.

#### 13) Map exchanges

Map exchanges are being disussed more and more in the Newsletter which the

executive feels should be encouraged.

Mrs. Kidd reported that the National Map Collection will be able to take a more active role in map exchanges shortly.

#### 14) A.C.M.L. Archivist

Mrs. Karen Lockhead who had been the A.C.M.L. archivist has left the National Map Collection. The executive agreed, that if possible, another member of the National Map Collection should be asked to take over the position.

#### A.C.M.L. Executive Meeting Tuesday, March 5, 1974

#### Publications Report

As mentioned in the October, 1973 A.C.M.L. <u>Newsletter</u>, the position of <u>Publications</u> Officer has been expanded to become a <u>Publications Committee</u>. Bob Hayward is co-editor of the <u>Proceedings</u>, and <u>Heather Maddick</u> has assumed <u>virtually full</u> responsibility for the distribution of our publications.

Bob and I have most of the material together for the Proceedings and hope to have them published and distributed begin the annual meeting in June.

Our publications continue to be popular, with requests coming in from many countries. Since A.C.M.L. conference in Banff, the following numbers of Proceedings have been sold:

1967 - 5 1968 - 3 1969 - 3 1970 - 4 1971 - 9 1972 -34 Total - 58

The revenue from these 58 volumes was \$242.00.

The bank balance in the Publications Account as of February 18, 1974 was \$480.20.

#### Activities:

The Chairman continued the draft of the MARC format for maps through September, October and November, 1973. The draft of the format is ready up to the first descriptive cataloguing element: The title area (tag 245). It became apparent at this point that no further progress can be made in the design of the MARC format until cataloguing rules for the material are drafted. Consequently, the emphasis of Committee work has now shifted towards a draft of "Canadian Rules for the Cataloguing of Maps, Charts, Plans, Atlases and related cartographical non-literary materials."

The first part of the draft, comprising rules for entry and descriptive rules for single or single thematic maps, up to, but not including the "Notes area" were completed by early February 1974 and distributed to the Committee members for study. A N.U.C. Committee meeting financed and sponsored by the Public Archives of Canada has been scheduled for March 4, 5 and 6, 1974 to discuss the first part of the draft of the Canadian Map Cataloguing rules. It is hoped that this first part will be accepted in substance at this meeting. The second part of the rules is presently drafted and may be discussed by the N.U.C. Committee at the Annual Conference of the A.C.M.L. in Toronto.

The chairman of the Committee Hugo Stibbe in his capacity of Registrar of Canadian Map Resources, attended a meeting of the Ontario University Libraries Cooperative System (Map) Group (OULCS Map) held on August 23, 1973 at Guelph University. The preliminary Canadian MARC format for maps was discussed at this meeting. Hugo Stibbe explained that the format is very preliminary indeed and that at this stage, the Ontario Group could not really contribute much to the format as such. It was agreed that keeping each other informed of what is happening would be mutually beneficial. Mr. Ralph Daehn who is chairing the Map Group is also a member of the N.U.C. Committee. This will insure proper communication between the Ontario University Libraries Map Group and the N.U.C. Committee.

Because the N.U.C. will, internally, use U.D.C. as the Classification for its Catalogue, a working group for the expansion of the Common Auxiliary of Place tables for Canada (71) was established under the Chairmanship of Hugo Stibbe, early in November 1973. No work has yet been done by this group.

#### A.C.M.L.-N.U.C. Committee working session, March 1974

On March 4, 5, and 6 the N.U.C. Committee members met in Ottawa to discuss the map cataloguing rules that had thus far been written by Mr. Hugo Stibbe. A number of observers were also invited to participate in the meeting.

The draft of cataloguing rules for single maps (<u>not</u> map series) consisted of chapters on entry, references, physical description, and an appendix on scale determination.

All sessions of the meeting were recorded on tape. Progress during the first day of the meeting was slow but the pace increased in the remaining period and all of the draft was discussed. By and large the rules were accepted: only fairly minor amendments were necessary. Those amendments have now been written by Mr. Stibbe and will be discussed by the N.U.C. Committee in the near future.

The meeting in March proved to be valuable and interesting to all those involved.

#### Article 1 Nom

Le but de l'Association est:

#### Article 111 Membres

L'Association sera composée de membres honoraires, de membres actifs, de membres moraux, et de membres associés.

#### Alinéa 1: Membres honoraires

Seront membres honoraires de l'Association les personnes qui auront rendu des services exceptionnels dans le domaine des cartothèques et toutes autres personnalités éminentes auxquelles l'Association aura conféré ce titre.

#### Alinéa 2: Membres actifs

Seront membres actifs les personnes qui se livrent au Canada au travail de cartothèque à plein temps ou à temps partiel.

#### Alinéa 2:

#### REPORTS FROM THE NATIONAL MAP COLLECTION

#### a) Resignation of Karen Lochhead

Karen Lochhead, Head of the Foreign Section of the National Map Collection, since 1968, resigned in March, 1974, after maternity leave and the birth of her second son, David.

Karen, after graduation in geography from McMaster University worked several years with the Geographical Branch, Department of Energy, Mines and Resources, doing research for maps for the current National Atlas of Canada. She transferred to the Public Archives in 1968 to organize and head the Foreign Section, which was based on 150,000 maps transferred from the Department of Mines and Technical Surveys in 1965. She thus became the first professional archivist in the National Map Collection with a geographical background.

Karen was one of the persons who initiated the 1967 meeting of map curators and map librarians held at the Public Archives. This organizational meeting resulted in the establishment of the Association of Canadian Map Libraries, in which Karen has always been active. She was the first Secretary-Treasurer, the second President and has served on and/or headed a number of committees including the National Union Catalogue of Maps, and the Committee on the Placement of Standard Bibliographical Information.

As head of the Foreign Section, she helped organize the government exhibits for the International Cartographic Association meetings in Montreal and Ottawa in 1972. In the same year, she prepared the first of the Foreign Section publications - List of Gazetteers in the Foreign Section. An article on the history and activities of the National Map Collection was prepared in co-operation with Betty May for the Special Libraries Association Geography and Map Division Bulletin in 1971.

Karen has had an interesting career in map custodialship and after her children are older, we feel she may return to the field.

#### b) Death of E.R. (Ted) Bateman

The staff of the National Map Collection were deeply shocked to learn of the sudden death of Ted Bateman on Saturday, March 16, 1974. At the time of his death, Ted was Acting Head of the Foreign Section.

Ted joined the Public Archives in January 1970 as a map control officer in the Foreign Section. Previously, he had worked as a member of the Canadian Armed Forces in the Mapping and Charting Establishment of the Department of National Defence. After his release in the late 1960's, he worked briefly in several government departments, including the Department of Forestry.

Ted's warm personality is being and will be sorely missed by the staff of the National Map Collection.

#### c) Publication programme

In 1974-75, the National Map Collection, Public Archives of Canada will publish several major and a number of smaller cartobibliographies, catalogues, and historical works based on cartography.

In the Public Archives of Canada Series, published by University of Toronto Press and Les Presses de l'Université Laval, a work on bird's eye views is being prepared by Edward Dahl and Betty Kidd.

Canadian cities will be featured in two publications now being edited - these are Ottawa in Maps by Thomas Nagy and Winnipeg in Maps by Alan Artibise and Edward Dahl.

A second volume in the provisional series describing the atlases in the Collection by country of origin by Lou Seboek will be concerned with early atlases published in France.

In addition, manuscripts are ready or nearing completion for "Maps relating to the Riel Rebellions" by William Oppen; "County maps of Canada" by Heather Maddick with an introduction by Joan Winearls; and "Maps of Prince Edward Island" by Louis Cardinal and Harry Holman. Expected publication date for these works is 1975-76.

The list of map series in the Foreign Section by Vivien Cartmell will continue in 1974-75.

The National Map Collection is also beginning a series of cartobibliographies/check-lists on various themes which arise from the daily work being carried on in the division. In this series, the following works will be amongst those published in 1974-75: "Township plans of the West" by Guy Poulin and Francine Cadieux; "The inch to the mile series" by Maurice McCauley; "The insurance atlases and plans in the National Map Collection" by Robert Hayward; and "Maps relating to telecommunications" by James Knight.

#### REVIEWS

a) J.B. Post, Issue Editor "Map Librarianship", <u>Drexel Library Quarterly</u>, October 1973, vol. 9, no. 4.

This issue of the <u>Drexel Library Quarterly</u> is devoted entirely to a study and explanation of map librarianship and is intended to act as a primer for beginning map curators. Editor Post has brought together eight articles by well known map curators who discuss such elements of map librarianship as cataloguing, classification and arrangement, conservation, acquisition, administration and others. My overall judgement of the issue would have to be that it should be made required reading for any aspiring map curator. In most cases the articles effectively introduce the major areas of map librarianship. A neophyte entering the field would find all of the articles most helpful in his orientation and in the development of his own theories concerning the various subjects discussed. Furthermore the short bibliographies listed at the end of each paper provide access to more advanced studies of each area.

Most of the authors have attempted to be objective in their writing so as not to appear as though they were advancing their own pet theories and practices at the expense of others. This objectivity is highly commendable and conforms to the intention of the issue, that is, exposing the beginner to the various theories and practices available. Unfortunately the article by Ralph Ehrenberg on non-geographic methods of map classification and arrangement does not tend to follow the same objective course. Mr. Ehrenberg gives an excellent description of the classification and arrangement of maps in the National Archives of the United States; however, he fails to note the deficiencies (of which there are many) in the systems used in that institution.

The only other criticisms one could feel justified in making concern the lack of any specific discussion on the handling, cataloguing and care of early maps and the lack of any extensive bibliography. A general bibliography would have been very useful and could well have formed a ninth and concluding paper.

These criticisms are minor however and do not substantially affect the value of the issue. As stated the articles included in the issue should be made required reading for the beginner; they would also prove useful and interesting to the more experienced map curator.

Officer); and "Maps to work on - maps to dream on" by Ron Scammell (Department of Energy, Mines and Resources).

c) Department of Energy, Mines and Resources, Facts from Canadian Maps: A Geographical Handbook, 1972 (1974)

This interesting little book, available from Information Canada (Catalogue No. M87-1/1974; \$1.50), contains data obtained from maps published by the Canadian government. Much of the information is in tabular form and provides statistical data on hydrographic features, mountains, coastal measurements, boundary areas, cities, and parks. There are handy notes on the availability of maps, charts, aerial photographs and gazetteers. A table of map scales and equivalents and other conversion tables are also included. Two maps - one relief map and a general map of Canada (MCR 18) - are in the book.

Although not published for the specialist in our field, you or a researcher might find the book helpful in quickly checking geographical facts.

#### a) Cartologica

- b) L.M. Sebert, Department of Energy, Mines and Resources delivered a paper on "The Use of Maps in the Exploration and Early Development of the Western Canadian Interior" at the I.C.A. Conference in Madrid, Spain recently.
